Health Care Jobs:

We utilized the dataset "County Business Patterns" published by the U.S. Census Bureau to determine employment in the health care sector. The dataset contains a record for each known business establishment in the United States and territories. The dataset utilizes the North American Industry Classification System (NAICS), developed by the federal Office of Management and Budget and used as the standard by federal statistical agencies in classifying business establishments. The "County Business Patterns" dataset does not include NAICS code 525110 "Pension, health, welfare, and vacation funds," which captures plan administrators and employees of self-insured employers. Accordingly, the data underrepresents the number of health insurance employees.

We evaluated each code in the "County Business Patterns" dataset and determined whether the code represented health care services, supplies, manufacturing or equipment. Codes identified as such were included as "health care jobs". NAICS divides the economy into 20 sectors, which are further divided by subsectors, which are further divided by industry groups. Health Care and Social Assistance is Sector 62. However, to count only the jobs in Sector 62 would be both over and under-inclusive.

Sector 62 includes Subsector 624 "Social Assistance," which includes Individual and Family Services (Industry Group 6241), Community Food and Housing and Emergency and Other Relief Services (Industry Group 6242), Vocational Rehabilitation Services (Industry Group 6243) and Child Day Care Services (Industry Group 6244). Including Subsector 624 would be over-inclusive as such jobs are too attenuated to the provision of health care services to be considered "health care jobs". Accordingly, we used the following Subsector codes in Sector 62 in our computation of health care jobs: Ambulatory Health Services (Subsector 621), Hospitals (Subsector 622), and Nursing and Residential Care Facilities (Subsector 623).

On the other hand, defining "health care jobs" as solely those jobs captured by Sector 62 would also be under-inclusive, as health care services rely on unique supply chains that include supplies, manufacturing and equipment that cannot be replicated by other manufacturers and distributors. Accordingly, we included such Industry Groups as: Pharmaceutical and Medicine Manufacturing (Industry Group 3254), Medical Equipment and Supplies Manufacturing (Industry Group 3391), Drugs and druggists sundries merchant wholesalers (Industry Group 4242) and Medical, Dental, and Hospital Equipment and Supplies Merchant Wholesalers (Industry SubGroup 42345) in our computation of "health care jobs". Likewise, we included Insurance Carriers (Industry Group 5241), with the important caveat that we used Industry SubGroups within the Industry Group to avoid overrepresentation of insurance employees.

Where possible, we utilized the Subsector code, rather than the Industry Group. For example, Subsector code 621 is identified as "Ambulatory Health Care Services," which includes Industry Groups 6211 "Offices of Physicians," 6212 "Offices of Dentists," 6214 "Outpatient Care Centers," et cetera. In the situation described, we utilized Subsector code 621, which is inclusive of all derivative codes. Where data was reported in a range, to prevent identification of a

reporting entity, we used the low end of the range. For example, where data was reported with a range of 100-250 employees, we used 100 employees in calculating overall health care jobs. For all of the reasons listed above, our totals are a conservative estimate of total health care jobs.

The dataset "County Business Patterns" reports all data on a county level, the most granular level of reporting that captures business establishments and employment data in a comprehensive manner. Legislative districts in New York do not precisely follow county lines; the district may be located wholly within a county, across county lines or encompass multiple counties. For this reason, we determined the job totals by code in each county. We then determined the proportion of the district's population to the population of the county. Where a district included multiple counties, such calculation was performed for each county of the district. This percentage was thereafter applied to the total employment of the legislative district, as reported by U.S. Census Bureau³, in order to determine "health care jobs" per district.

Below, sorted by group, are the 95 codes out of 2209 NAICS codes that we determined represented health care jobs. "Health care" jobs in New York State totaled 2,108,363 jobs. The federal Bureau of Labor Statistics reports that total jobs of 9,242,900⁴ in New York as of February 2019, making health care jobs approximately 22.8% of all jobs. We additionally identified code 52411 "Direct Life, Health, and Medical Insurance Carriers" as health insurance jobs that would be eliminated under the NYHA. Statewide jobs classified under the 52411 code equaled 60,527.
